Prospectus:

Juror: Professor of metalworking/enameling at East Carolina University, Linda Darty has an extensive national and international exhibition record including work in the permanent collections of the Victoria and Albert Museum, and the Museum of Art and Design in NYC. She is the author of *The Art of Enameling*, published by Lark Books in 2004. Her work has been featured in numerous publications including Lark Books: 500 Enamels, 500 Vessels, 500 Brooches, and Craft International Magazine. Ms. Darty has received the North Carolina Board of Governor's Award for Teaching Excellence, the ECU Alumni Teaching Excellence Award, Scholar Teacher Award and the Lifetime Achievement Award from the Enamelist Society.

Eligibility: Open to all enamel artists. Original work must be made in the last two years with primary emphasis on enamel and not previously shown in Studio 5 or Gallery 21. Entries must have a U.S. return address.

Entries/Fee: Entries juried by digital image CD. Fee is \$25 for up to four jpeg images.

Digital Images: All entries must be digital image format at jpeg 72dpi with the maximum length of 640 pixels on either side. One image for each entry is required and a second image of the same work may be submitted for details. Name image files with your last name and number of the entry on the entry form (ex. Jones 1). Name details to correspond to main image entry. (Ex. Jones 1) SDEG assumes the right to use the submitted images for advertising purposes.

Specifications: Work must not weigh over 50 lbs., not exceed 5' x 3' in size, or have a value of more than \$5,000. Special installations need to be accompanied by instructions or diagrams.

Liability: Gallery 21 carries no insurance. Please self-insure. Gallery 21 is well protected and two attendants will be on duty during open hours. Work will be handled with the utmost care. Our installers are professionals and understand the fragility of enamels.

Awards: Several cash and merchandise awards will be given, including the \$300 Shirley Lichtman Memorial Award.

Notification: Include a self-addressed stamped envelope (SASE) for notification. Artists accepted into the exhibition will receive any additional shipping information with their notification of acceptance. Digital images will not be returned. We assume permission to reproduce images for exhibition advertisement.

Shipping: Work accepted into the exhibition must be sent with return postage to a U.S. address prepaid. Art work is to arrive in San Diego no later than September 15. Work must be in a strong, reusable container that can be easily repacked. Unsold work will be returned in the same container. Return postage is the responsibility of the artist. Hand delivered work brought to Studio 5 in Spanish Village no later than September 30. This, too must be in a strong, reusable container. All work is to be shipped to:

Sales: All pieces must be for sale. There will be a 30% commission on work sold (20% to Spanish Village and 10% to San Diego Enamel Guild.) The SDEG treasurer will pay the artist within 30 days of closing the show. All pieces will remain in the exhibition until its closing on October 25 at 4:00 p.m.
