- A non-refundable deposit of \$225.00 is due at the time of signing of the rental agreement; **the balance of the rental fee (\$200.00) is due 60 days prior to the exhibit.**
- *A refundable deposit of \$50.00, by separate check, for gallery/kitchen cleaning is also required.
- Exhibit dates are not confirmed until the delivery of the “official” Rental Agreement Contract and deposit.
